16. Election of Chair and Vice-Chair

It was proposed by Councillor Andrew, seconded by the Mayor, and unanimously
 RESOLVED – that Councillor Benyon be elected Chair of the Committee for the ensuing year.

It was then proposed by Councillor Andrew, seconded by the Mayor, and unanimously
 RESOLVED – that Councillor Willey be elected Vice-Chair of the Committee for the ensuing year.

18. Minutes of the Finance & General Purposes Committee
